
Selected list of books and journals for the small medical library*

The introduction to this revised list (seventeenth version) of 610 books and 141 journals addresses the origin, three decades ago, of the "Selected List of Books and Journals for the Small Medical Library," and the accomplishments of the late Alfred N. Brandon in helping health sciences librarians, and especially hospital librarians, to envision what collection development and a library collection are all about. This list is intended as a selection guide for the small or medium-size library in a hospital or similar facility. More realistically, it can function as a core collection for a library consortium. Books and journals are categorized by subject; the book list is followed by an author/editor index, and the subject list of journals by an alphabetical title listing. Due to continuing requests from librarians, a "minimal core" book collection consisting of 78 titles has been pulled out from the 200 asterisked (*) initial-purchase books and marked with daggers (†). To purchase the entire collection of books and to pay for 1997 journal subscriptions would require \$101,700. The cost of only the asterisked items, books and journals, totals \$43,100. The "minimal core" book collection costs \$12,600.

The year is 1965. The month is July. The publication is the *Bulletin of the Medical Library Association*. The volume is 53. The pages are 329–64. The article is the "Selected List of Books and Journals for the Small Medical Library." The author is Alfred N. Brandon. The rest is history—or maybe it could be described as a phenomenon! From its initial appearance in 1965, the "Brandon List" (later "Brandon/Hill List") was a resounding success; people really needed this kind of

information. As a result, an updated version of this article has appeared biennially in the *Bulletin of the Medical Library Association* for three decades. Over the years, thousands of reprints have been distributed throughout the world.

At the time of Al Brandon's unexpected death in July of last year, we were in the midst of gathering data for and working on the 1997 revision (seventeenth version). Because so much of my coauthor's work is reflected in this update, he has been listed as the senior author. About three-fourths of the books considered as possible "list candidates" were reviewed by both of us. The remaining books have been reviewed by me—first trying to evaluate them as Al Brandon would have done and then, secondly, from my point of view. He had prepared all of the requests for basic data that we needed from publishers to update our book list. We had reviewed the journal list at great length and de-

cided to make no changes this year. I had brought up two additional journals for consideration, but we planned that they would be dealt with in the introductory text material, at least for this update.

For the past ten years or more, it had been our mission to explore the interrelationship of print and electronic media in the hospital library and to see if the "Selected List" still had relevance both currently and in the foreseeable future. These discussions usually were the bases of the introductions that preceded the book and journal lists. From the number of telephone calls that I have received since July 1996 regarding the importance and the continuance of the "Selected List," I believe that there is already a convinced audience. Therefore, I feel that under the circumstances, it might be more fitting to take a retrospective look at the origin of the "Selected List" and the unique impact that Al Brandon has had upon the health sciences library community.

The idea for a "Selected List of Books and Journals for the Small Medical Library" occurred to Al Brandon when he was director of the Welch Medical Library of the Johns Hopkins School of Medicine in Baltimore. In his previous position he had built a new health sciences library collection, which supported colleges of medicine, dentistry, and nursing, at the University of Kentucky in Lexington [1, 2]. Prior to that, he had assembled a dental library collection at Loma Linda University to meet the needs of their new dental school. Obviously, he had a strong familiarity with the concepts of collection development in health sciences libraries long before the term was even coined in the profession. He also was in the process of revamping, organizing, and updating the huge collection in the Welch Medical Library.

In Baltimore there was, at that time, a very active hospital librarians' association, and he attended their meetings on a regular basis as director of the Welch Medical Library. It was from his interaction with this group that Al Brandon became a champion of the hospital library and the hospital librarian. He felt that, in spite of their great interest and enthusiasm, these librarians did need guidance. Some of them were not academically credentialed as librarians. They wanted to do a good job, but often did not know exactly what to do or how to do it. Their problems were especially overwhelming when it came to selecting books and journals.

As a result of his work with these hospital librarians, Al came to the conclusion that it was about time to have a reference tool or selection guide geared toward hospital and small medical libraries, because comparable situations probably existed in hospital libraries throughout the nation. The most useful list of its time was published sporadically by the American Medical Association (AMA) between 1940 and 1959 [3], but it was out of date by the mid-1960s. The AMA

had announced that this publication would no longer be revised. So having to start somewhere, Al Brandon used the 1959 version of the AMA list as a base document and went on from there to request help from medical colleagues at Johns Hopkins and the University of Kentucky College of Medicine. Nurses and hospital librarians were also asked for their opinions. From this background, in July 1965 the initial "Selected List of Books and Journals for the Small Medical Library" appeared. (In instances where I have referred to various versions of this publication, I have not referenced them since a complete bibliographic note appears at the beginning of the introductory text.)

It is easy to understand why the "Brandon List" achieved almost instant popularity. At the time of its initial publication, this piece of work provided a document for hospital librarians that contained a contemporary list of books and journals recommended for the hospital library by an authoritative source, the then director of the Welch Medical Library. Equally important, it gave hospital librarians a tangible means of impressing upon the minds of their administrators the actual cost of purchasing health sciences books and journals, since prices were included.

Al was already well known in the academic medical library community as a result of his years at the University of Kentucky. During that time he had written to all academic medical library directors in the United States to find out if they had duplicate material to donate, and if they did, he paid them personal visits. Many of those duplicates ended up in the Kentucky collection, thereby reducing the cost of the original collection significantly. From these contacts, many academic medical librarians may have become interested in the "Brandon List" because they were personally acquainted with its author.

It should be remembered that in 1965, book and journal vendors were not providing to their customers the kind of support data—both bibliographic and financial—that they do today; nor did we have the various modes of rapid communication that now exist. While the idea of a selection guide of this kind did not originate exclusively with Al Brandon, he did perceive a need for keeping the information current and recognized how fast it was outdated. To address this situation, he made the "Brandon List" his priority, a permanent, revolving project on a fifty-two-week-per-year basis. By doing this, he was able to publish updated versions every two years. The stability and quality of the "Selected Lists" stand out among Al Brandon's many contributions to health sciences librarianship. In 1972, he was awarded The Ida and George Eliot Prize, a yearly award given by the Medical Library Association for the work published in the preceding year that was judged most effective in furthering health sciences librarianship.

I became unofficially involved in the "Brandon List"

during the 1970s. I worked at Mount Sinai (New York) as acquisitions librarian; Al Brandon was director. In that capacity, I was viewing and handling many books every day. I began to call to his attention books that I thought should be considered for the "Brandon List." After a while, he began asking for my opinion on titles to be included in the "Selected List."

After becoming more and more engrossed in the project, I emerged as coauthor with the publication of the 1979 "Selected List." Over time the "Brandon List" slowly began to evolve into the "Brandon/Hill List," but that evolution is by no means complete; it is still frequently referred to as the "Brandon List."

The original "Selected List" has had two spinoffs—nursing (1979) and allied health (1984). Al and I worked together on both of them from their inception. They too have been updated biennially. There have been nine versions of the nursing list and seven of the allied health list.

In the 1970s and the 1980s, many nursing and allied health programs were moving from hospital to academic settings, and selection guides were needed especially by academic librarians who had little familiarity with health sciences books and journals. The need was particularly great in community colleges to which programs were being transferred. Al Brandon had long had an interest in nursing literature that began with his association with the *Cumulative Index to Nursing & Allied Health Literature (CINAHL)* back in the mid-1950s. He continued as the CINAHL representative to the Interagency Council on Library Resources for Nursing (now the Interagency Council on Information Resources for Nursing) until a few years ago. In the early 1970s, I had set up a new nursing collection at Mount Sinai. Because of the success of the "Brandon List," Al had been asked repeatedly by various nurses and nursing groups to put together a comparable list of nursing books and journals. After some procrastination, we decided to take on the task since we both had a well-grounded knowledge in nursing literature. Our first nursing list was published in 1979 [4]; the current version in 1996 [5].

The allied health list was definitely the most difficult of the three. The umbrella term "allied health" covered a lot of territory; we were not sure exactly what the boundaries were, and apparently neither was anyone else. When we began, we knew far less about this body of literature than we did about the literature of medicine and nursing. We started to work on it in 1981 and published the first allied health list in 1984, three years later [6]. Our primary audience was intended to be academic librarians who had to develop collections in allied health literature and had very little or no subject background. Much to our surprise, many academic health sciences librarians told us that this was, for them, the most useful piece of work that we had done because they had no handle on this segment

of the health sciences literature. The most current allied health list was published in 1996 [7].

Shortly after Al Brandon had resigned his position at the New York Academy of Medicine and moved to Florida in the late 1970s, he became a consultant to Majors Scientific Books, Inc. In this capacity, he was able to expand his collection development interest by originating and editing a quarterly newsletter titled *A Major Report*, which served as an interim supplement to the book sections of the "Selected Lists" [8]. The first issue was published in the fall of 1979 and was another immediate hit! The last issue that Al Brandon edited was volume 17, number 3, summer 1996. Majors Scientific Books intends to continue its publication on a quarterly basis. Volume 18, number 1, winter, 1997, has been published; I supplied interim book information for this issue, and I intend to do so in the future. However, I shall not be editing *A Major Report* as Al did.

While collection development encompasses all media, the one that Al Brandon was the most interested in was the medical book—you might describe him as a champion of the medical book! He believed that the print book would always remain, even though it would be supplemented by other media formats, some of which we are not even aware of yet. He frequently stated that in his opinion, the medical book has been overlooked in recent years as a basic information tool. Too often the medical book has been described by many health sciences librarians as relatively useless because of its supposedly being out of date by the time it is published. To him, the purpose of the medical book was to provide basic knowledge in context, rather than cutting-edge technology.

The status of the "Selected List of Books and Journals for the Small Medical Library" is a phenomenon in this electronic age. It is still being used throughout the world, not only by librarians but also by health care providers. After thirty-two years, its content and format remain very much the same.

During the heyday of the Regional Medical Library Program in the 1970s, when the hospital library was expected to have an up-to-date basic book and journal collection to fill the immediate needs of its primary clientele, the "Selected List" was used heavily as a standard for development grant proposals. Over the years, instead of being considered as *one* of various sources for collection development, the "Selected List" was fast becoming the etched-in-stone standard for the hospital library collection; this aura still exists today. Al was quick to point out that inappropriate book and journal choices from the "Brandon/Hill List" are as costly as those made from any other source. In the first "Brandon List" he clearly stated that the books and journals that he had recommended should be weighed against institutional programs and needs before being acquired.

Since 1994, the Joint Commission on Accreditation of Healthcare Organizations (JCAHO) has designated the "Selected List" as a source to consult for authoritative up-to-date resources for the hospital library (Standard IM.9.2) [9]. JCAHO endorsement further increased the importance of the "Selected List" as a collection development tool for hospital libraries. It is reassuring to know that the JCAHO considers print media to be part of the biomedical knowledge base.

The legacy that Al Brandon has left to health sciences librarianship is awe-inspiring. In the preceding paragraphs, I have briefly mentioned only one aspect of his work, collection development, which I know was his favorite subject.

Early on, I mentioned that Al and I had discussed two journals for inclusion in the 1997 "Selected List." We were mulling over various subjects that might be suitable to explore in the context of the hospital librarian and the hospital library. One of the topics that we came up with was evidence-based medicine, currently a very hot topic at Mount Sinai. We had read a couple of articles [10, 11] on evidence-based medicine, and reviewed two journals, *ACP Journal Club*, published by the American College of Physicians, and *Evidence-Based Medicine*, published jointly by the American College of Physicians and the BMJ Publishing Group. The purpose of both of these journals is to link research to the practice of medicine, but since they are quite different from the journals in the "Selected List" they have not been included in this update. We knew that to make a presentation on this subject would take a lot of work, which, under the circumstances, I was not able to do. I have seen two interesting articles relating to health sciences librarians and evidence-based medicine [12, 13]. This subject will be very much with us during the coming years and should at least be mentioned here, since it will likely play a part in the lives of many hospital librarians.

The list of books and journals that follows has traditionally been used as a planning tool for developing or updating a library print collection in a hospital or comparable facility involved primarily in patient care. It has also been used as a guide for a core collection for a consortium or network sharing library resources. As book and journal prices continue to increase, cooperative resource-sharing may very well become the primary use of this list. The choice of books and journals in the 1997 list is the result of our having monitored current health sciences print literature over the past two years, as well as our extensive collection development experience. As I previously stated, about three-fourths of the books that we chose for tentative inclusion in the "Selected List" were reviewed by both Al Brandon and me.

As in the past, I have attempted to assemble a well-balanced current collection of authoritative English-language books and journals, primarily in the clinical

sciences although clinically relevant basic sciences books have been included. Basic sciences journals have been omitted because most hospital libraries cannot justify the extremely high subscription costs for low-use material, and the fax machine makes the contents of these journals readily accessible. If basic sciences journals are required, they should be purchased on a resource-sharing basis with other libraries. The journal list is not intended to support research activities.

Most, but not all, of the publications originate in the United States. When two books appear to be of comparable content and authorship, the most recently published one has been chosen. In the 1997 book list, 93% of the books have been published in 1994 or later; no books have been published before 1989. Because we have emphasized current books, some of the standard works that have not been revised for several years have been dropped from this list. Newly updated editions of standard works that did not appear in previous editions may reappear in this one. About 41% of the book titles from the 1995 list have been deleted from the 1997 one. Newer is not necessarily better, but current literature has been the priority in these lists.

If at all possible, I have tried to include inexpensive alternatives to expensive books, but in many subject areas inexpensive quality books do not exist. In choosing publications for this list, I have taken into account comments, criticisms, and suggestions from health sciences librarians, subject specialists, and clinicians as Al Brandon and I had always done. In this update, the final choices have been *my* decisions. Price information has been supplied by publishers and vendors and is as accurate as I could obtain at the time of manuscript submission. Price increases are to be expected. This list is, as the title implies, limited to print media—books and journals. A hospital librarian who must purchase audiovisuals or microcomputer software, but lacks knowledge of such media, should request assistance from another hospital librarian who has initiated a successful media program or from an academic media center.

In addition to the "Brandon/Hill List," the JCAHO has designated "A Library for Internists" as another source for identifying authoritative and up-to-date scientific, clinical, and managerial knowledge for hospital libraries [14]. This annotated list reports the recommendations of the American College of Physicians; it has been updated triennially since 1973 and is published in the *Annals of Internal Medicine*. The focus of this work appears to be shifting from print to electronic media.

Doody's Health Sciences Book Review Journal was initially published in January 1993 and holds an endorsement from the Medical Library Association [15]. This publication analyzes and reviews published titles from 135 publishers worldwide, encompassing nearly ninety specialty areas. At the end of each review there is

a numerical rating given by the reviewer which is known as the Doody number. According to the publisher, no book reviewed is older than six months. There have also been spin-offs from the main title.

A number of reference books are included in our list, but we have not attempted to present a comprehensive coverage of reference sources for the hospital library. Extensive information on biomedical reference material can be found in Roper and Boorkman's *Introduction to Reference Sources in the Health Sciences* [16]. The Interagency Council on Information Resources for Nursing compiles a guide titled "Essential Nursing References," which is revised biennially [17]. It is an up-to-date list that a hospital librarian can use in developing a reference collection. It contains both nursing reference items and standard biomedical reference works, along with a Canadian supplement.

A *Core Collection of Medical Books and Journals* is published in London as a British and international alternative to the "Brandon/Hill List." The second edition was published in 1994; it is scheduled to be updated every two years. Coverage of the British list is primarily clinical [18]. An excellent core collection for minority people was published in the winter of 1995 [19] in the *Medical Reference Services Quarterly*.

Administrators of patient-focused hospitals are extremely concerned about patient education and consumer health. This is the ideal entrance point for the hospital librarian to become part of the clinical care team. It is also an opportunity for hospital librarians to explore the entire scope of patient education and consumer health informational sources, both electronic and print. The standard work in this field is Rees's *The Consumer Health Information Source Book* [20]. The *Library Journal* often has useful collection development articles dealing with consumer health and patient education [21, 22]. Login Brothers, Majors Scientific Books, and Rittenhouse Book Distributors have provided assistance to hospital librarians in dealing with popular health publications; undoubtedly other book vendors also offer comparable services. One of the most useful publications on the Internet that I have seen is titled *Health Care on the Internet*; it should be in every hospital library that has access to the Internet. One of its goals is to publish articles on finding information on the Internet pertaining to specific diseases or conditions [23].

Approximately \$101,700 would be needed to purchase all of the 610 books and 141 journals (1997 subscriptions) on this list—\$69,900 for books and \$31,800 for subscriptions. This is the first time that the total cost has reached \$100,000. Items suggested for first purchase, 200 books and 60 journals, are designated by asterisks, because many hospital librarians cannot afford or may not need all or even most of the listed publications. The cost of the asterisked books and journals is approximately \$43,100—\$28,600 for books and

\$14,500 for 1997 subscriptions. In response to the requests of many hospital librarians, the "minimal core list" of seventy-eight titles will be continued. These books are marked with daggers before the asterisks (†*). The "minimal core list" is made up of books that a librarian might acquire if he or she could purchase only one or two titles from each of the major subject categories, with the exception of dictionaries, directories, and encyclopedias where several titles have been included. The cost of the "minimal core list" is \$12,600. Book price totals are based on one-volume editions in instances when books have been published in either one- or more expensive two-volume formats and on "nonmember" prices when indicated for association prices.

The increases in book and journal prices for titles in this list and its previous versions are shown in Table 1. From 1965 to 1997 there has been an increase of 664% (\$15.00 to \$114.57) in the average price per book title. During the same thirty-two-year period, the average price per journal subscription has increased 1,523% (\$13.19 to \$225.63).

The figures stated here apply only to publications that appear in this list or have appeared over the years in its predecessors. The "per-title" calculation includes the cost of all volumes in a multivolume set. The average volume price for the 670 books that make up the 610-title book collection is \$104.31, \$10.26 less than the per-title average. In instances where a title appears in either one or two volumes, it has been considered as one volume in the physical volume count. Titles do vary from list to list, but the cost figures are represen-

tative of those being incurred by hospital libraries in acquiring current books and journals. Most of the journal titles are domestic, and therefore do not reflect higher prices frequently charged by foreign publishers. Even so, 91% of the journals cost \$100 or more while only 43% of the books have reached that status.

The book titles in this list are divided into fifty-four subject categories and the journals into forty-three. No new subject categories have been added or deleted, although Al and I had thought about adding Alternative Medicine and Managed Care. Unfortunately, I have not had time to review the literature on those subjects. Any books containing material on managed care have been categorized under Hospitals and Administration. For hospital librarians who need help acquiring nursing and allied health publications, I have mentioned before the nursing and allied health lists published by Al Brandon and me in 1996.

For new editions appearing in early 1997, I have indicated prices if they were available when the manuscript was submitted; if it was impossible to obtain prices and tentative publication dates, I have used the phrase "in preparation" for books due in mid or late 1997.

If a book has more than two authors or editors, the notation "[and others]" is made after the name of the senior author or editor. In the index of authors and editors, I have included only the senior persons; coauthors and coeditors do not appear. If the name of the original author or editor is an integral part of the book title, that name appears in the index.

Because of mergers, takeovers, and the changing of publishers' names, the imprint on a book may not necessarily be indicative of the publisher who is presently distributing the book. The most notable recent change is the takeover of Little, Brown (health sciences) books by Lippincott-Raven. I have tried to cite the books by using the names of the publishers who are currently distributing them. As a matter of course, I routinely indicate the publisher from whom a book can be obtained in the United States if it is not of U.S. origin.

Al Brandon has left a significant imprint on the profession of health sciences librarianship, especially in the field of collection development. He found a formula that clicked and the "Selected Lists" came into being. He was truly dedicated to working on the "Selected Lists" and *A Major Report*. I believe that after his death, many of us have come to realize how monumental Al Brandon's achievements were, at a time when the profession needed stability. He will still be around as long as his legacy, health sciences librarianship, is thriving and prospering. Probably the best way to sign off and remember him is by recalling his own words:

How do we cope with all this change? Using tradition! Our tradition has always been to collect, organize, store, and disseminate information in the most efficient manner that the

media of the times have had to offer. Some of us have carried out this tradition as keepers of books while others have done it as information scientists, but the results have been the same. Today our professional lives are shaking from change, but we still have a tradition which technology cannot change—unless we let it [24].
