The labels for validation of microarray results, depicting qRT-PCR assays of

KIRD3S1 and PRF1 genes were inadvertently swapped. The correct KIR3DS1 and PRF1 qRT-PCR values are now depicted in the updated article online. This is in-line with Supplemental figure 1B, showing that KIR3DS1, and not PRF1, is the most discriminating gene between moderate and severe CCC.
