

do not change that reality. They simply require that people with disabilities be considered fairly, as individuals, and based on evidence rather than on stereotypes and assumptions. The RFI and other recent legal developments underscore these basic guarantees and the work that must be done to ensure equal access for people with disabilities in organ transplantation.
