Notes: The Health and Retirement Study (HRS) collects psychosocial data every other wave using a self-administered questionnaire (SAQ) which is left behind with participants at the end of the enhanced inperson interview. Each wave, a rotating random 50% sample of the larger core HRS sample is assigned to complete the SAQ. This analysis examined how social isolation and covariates in an index year (Sample A: 2006, 2010, 2014; Sample B: 2008, 2012, 2016) impacted outcomes (hospitalization, skilled nursing facility stays, nursing home placement) over the subsequent 2 years (Sample A: 2008, 2012, 2016; Sample B: 2010, 2014, 2018).
