Sample size	Figure 4 presents the average annual percentage change of gabapentinoid consumption over the span of 11 years, from 2008 to 2018. Gabapentinoid consumption is presented as defined daily dose per ten thousand inhabitants per day. The mid-year population estimates of each country was obtained from the UN Population Division in 2019 and each individual country has a different population in each year.
Data exclusions	No data was excluded in the main analysis of the study.
Replication	The first two authors have conducted the statistical analysis independently using the same set of MIDAS data from IQVIA. The results presented in the manuscript were cross-checked by the first two authors using different statistical analysis programmes (SAS and R) to ensure reproducibility. All attempts at replication were successful.
