However, the vast majority of original studies that the GDM precision medicine working groups reviewed used 'women' as their terminology to describe their population, as GDM per definition occurs in pregnancy which can only occur in individuals that are female at birth. To be consequent with the original studies defined populations, we use the word 'women' in our summary of the evidence, current gaps and future perspectives, but fully acknowledge that not all individuals who experienced a pregnancy may self-identified as 'women' at all times over their life course.
