Commercial softwares Andor Solis, and Lightfield are used in data collection from visible and near-IR spectrometers, respectively. The commercial software ThorCam is used in imaging experiments.

The simulation and spectrometer measurements are plotted using the built-in functions of MatlabR2021a (plot, surf). The efficiency calculations are also performed by the same software using fundamental mathematical operators. The calculations are described in the paper as equations. No custom functions are used
