Sample size	These datasets were randomly split into training and test sets, 80% and 20%, respectively. The performance was evaluated directly from the test set without any assumption of underlying distributions. The number of samples is large enough to train a machine learning model, as evidenced by its excellent performance on an independent test set and the DLKcat instruction.
Data exclusions	We excluded samples with substrate simplified molecular-input line-entry system (SMILES) containing "." or kcat values less than or equal to 0, as per the DLKcat instruction.
Replication	The model parameter is available as standalone software to run on a local computer for results replication.
Randomization	All datasets were randomly split into training and test sets to ensure a fair comparison. And based on the goal of enzyme evolution, samples with the highest enzyme kinetic parameters predicted by UniKP were selected for experimental validation.
Blinding	For a fair comparison, the test sets used for UniKP performance measures were completely independent of data used for model training. And we made a comparison based on different sequence similarity. We were not blinded to allocation during experiments and outcome assessment.
