Timing	from database inception to March 2022.
Data exclusions	As our main goal was to review studies identifying GDM sub-phenotypes beyond glycemia, we excluded studies that only reported on glycemic markers or thresholds (e.g., HbA1c, fasting glucose, oral glucose tolerance test [OGTT] glycemic values), or studies that were focused on assessing differences in outcomes based on timing of glucose measurement. We also excluded studies that 1) measured the precision marker after GDM diagnosis (e.g., total gestational weight gain [GWG] over the whole pregnancy, or fetal biometry after 32 weeks' gestation), 2) combined pre-existing diabetes or overt diabetes (based on non-pregnancy glycemic thresholds) with GDM, 3) included women with multi-gestations, or 4) did not contain full-length manuscripts in English.
