Replication	Our experimental procedure basically followed to the previous study (Linden et al., 2010). Our results were partially consistent with the previous dataset, indicating the reproducibility of the resulting dataset.
Randomization	For our RNA-seq analysis, we sampled experimental groups in a random order to avoid experimental covariates.
Blinding	The complete blinding was not possible, because the experimenter could visually detect whether each sample was in the treated condition or not.
