These items are the basic minimum to include in a manuscript. Without this information, readers and reviewers cannot assess the reliability of the findings.

The sample size of animals was calculated using the software G Power (Faul, Erdfelder, Lang, and Buchner, 2007), employing the formula for corrected sample size = sample size / (1 - [% attrition/100]). The software calculated a sample size of 8 rats with 10% attrition, resulting in a determination of 9 rats per group for this study.
