Data collection

The gene expression profiles for 18 cancer types from the Cancer Genome Atlas data portal (TCGA) and non-cancerous tissues from Genotype Tissue Expression (GTEx) consortium were downloaded from the UCSC Xena platform (<http://xena.ucsc.edu/>). Gene expression profiles of PRAD were downloaded from the International Cancer Genome Consortium (ICGC). Gene expression profiles of GBM were downloaded from the Chinese Glioma Genome Atlas (CGGA). Clinical data was also downloaded from the UCSC Xena platform. Also, we collected ICPs by handbooks or instruction of website from multiple companies. Only clinical and experimentally verified ICPs were collected. Ten scRNA-seq expression profiles including lung cancer, Colon adenocarcinoma, Liver Hepatocellular Carcinoma, cholangiocarcinoma, Head and Neck squamous cell carcinoma, Breast invasive carcinoma and melanoma were downloaded from Gene Expression Omnibus (GEO, <https://www.ncbi.nlm.nih.gov/geo>)

Data analysis

The R code and Python code were used for the identification of ICP-LncCRCTs. R codes were also used for the analysis between ICP-LncCRCTs and immunity, and with prognosis of melanoma. Replication

All replication attempts were successful. The framework for identifying ICP-LncCRCTs was also validated in the GBM and PRAD datasets obtained from CGGA and ICGC.

Randomization

Random perturbations were used in identifying gene pairs consisting of lncRNAs and ICP genes with possible regulatory relationships in ICP-LncCRCTs. 1000 random perturbations were performed by perturbing the sample labels and calculating the FDR by Benjamini and Hochberg (BH) correction.
