Participating in this study will involve completing a secure online survey which takes about 5 minutes. Your answers will be kept completely anonymous and will not be linked to your email address.

Next steps: If you meet our inclusion criteria below and agree to participate, then you will be asked questions regarding Second Look programming that took place during the 2022-2023 Match cycle. The survey will be administered through REDCap, a HIPAA compliant, secure survey management application hosted at SUNY Upstate Medical University. Your responses will be recorded and stored in REDCap, and only the research team has access to this data. The researchers will never share information that might identify a participant. The de-identified data, including anonymized quotes, may be used in academic research papers, published articles, and conference presentations. Your de-identified information may be used for future research without additional informed consent.

Inclusion criteria: Program director for a Radiation Oncology residency program in the United States.

Discomforts and risks: The discomforts and risks to you are minimal. Potential risks include feeling uncomfortable answering questions about the residency match process. You have the right to refuse to answer any question at any time. You have the right to stop participating at any time while taking the survey and the right to exit the survey at any point while taking it.
