Purity is approx. 95% and Endotoxin content is 0.2 EU per milligram; B12 is originated from a HIV-1 donor. this mAb was expressed in CHO cells and purified by Protein A affinity Chromatography.

Sample preparation	CD4+ T cells were isolated from normal healthy donors, activated for at least 5 days in the presence of anti-CD3 and IL2. SF162 virus was obtained from the NIH AIDS Repository. mAbA32 and VRC01 were provided by the NIH AIDS Repository. Cell

staining was carried out using standard procedures. Briefly 200,000 cells were stained with 1 ug of primary antibody in a volume of 150 ul of FACS staining buffer. After rinsing, cells were stained with 1 ug of PE conjugated goat anti-human IgG. Data was collected on a FACS/CANTOII, and analyzed with FLOW JO and PRISM softwares.
