Data collection	Data was collected at Diamond Light Source synchrotron facility using Generic Data Acquisition (GDA) software. GDA provides a common Python syntax scripting environment with Graphics User Interface and Object customisations, used for data acquisition at most Diamond Light Source beamlines.
Data analysis	aXis 2000 software package, Oct2019 version (available at http://unicorn.mcmaster.ca/aXis2000.html) was used for processing and analysis of x-ray spectromicroscopy data. Java-based image processing program, ImageJ version 2.1.0/1.53c, was used to apply a bandpass filter to images and to create pseudo-coloured composite images.

Sample size	The work presented constitutes an exploratory, proof-of-concept, study to evaluate the utility of synchrotron x-ray spectromicroscopy for intranuclear iron characterisation. As such, a single case (n=1) was used to demonstrate this.
Data exclusions	No data exclusions
Replication	Intranuclear iron was consistently shown to be in the same ferric oxidation state across multiple neurons measured. Repeat scans were also used to verify scanning parameters, with no evidence of beam-induced changes to the iron oxidation state. This confirmed measurements to be reproducible.
Randomization	Randomisation was not relevant to this study due to the small sample size
Blinding	Blinding was not relevant to this study due to the small sample size
