Given the high reproducibility, a sample size of at least $n=2$ for the in vitro spectroscopy assays was determined to allow adequate analysis and conclusion. Given the higher variance observed for the in vitro experiments with FUS droplets/PIC and in-cell experiments, sample sizes of $n=150$ and $n=50$ (respectively) were determined to be sufficient for adequate analysis and conclusions.
