Sample size	Sample sizes were determined using power analyses and standard deviation was estimated based on previous data from our groups or published in citations provided
Data exclusions	No data was excluded, unless stated in the manuscript. For the elevated zero maze, mice that fell of the platform during the testing were removed from the study. For fiber photometry, animals lacking sensor expression or fiber misplacement were excluded.
Replication	Experiments were run with replicate samples whenever possible. For behavior, independent cohorts of mice were run to test replication. For example, mice behavior was run in several cohorts and the main observations were reproduced. For PCR, radioligand binding and Blood ethanol concentrations, samples were run in replicates and averaged. All these information is stated in the manuscript.
Randomization	When mice were run on multiple consecutive behavioral tests, the order of the tests were randomized using a latin-square design. For experiments in Fig. 1 G-I, all mice were tested in alcohol stimulation first and then randomly split in two groups of each sex proportions and run on the EZM with either saline or alcohol.
Blinding	Experimenter was blind to condition when doing the data analysis.
