We are studying the temporal properties of the eye's optics using wavefront sensor measurements and retinal images, and have no reason to believe sex or gender plays a substantial role.

Subjects self-reported their age as 38.1 + /- 17.2 years (mean+/- STD), with a range of 20 to 76 years. The university optometry clinic screened the normal, nystagmic, keratoconic, and myopic subjects.

Subjects were recruited through flyers, email advertisements, word of mouth, and referrals from clinical staff of the university optometry clinic, who were informed about our study.
