Study description

We define the microbial terroir of vineyards across the 12 sub-areas (Additional Geographic Units -AGUs) of the "Consorzio del Vino Nobile di Montepulciano DOCG" PDO area (Italy), a world-renowned wine-producing region.

Research sample

Rhizospheres of *Vitis vinifera* cultivar Sangiovese and soil samples.

Sampling strategy

Grapevine roots and soil samples were collected from the 12 production areas (AGUs) within the "Consorzio del Vino Nobile di Montepulciano DOCG" PDO area in Tuscany, Italy. All plants were *V. vinifera* cultivar Sangiovese, apparently healthy, more than 15 years old and used for the production of Vino Nobile di Montepulciano. Sampling was carried out at 4 different time points throughout the production season in 2022 (i.e., pre-harvest in July, August and September, and post-harvest in October) for a total of 336 root samples and 56 soil samples. Specifically, for each of the 14 vineyards, 6 rhizospheric samples and 1 bulk soil sample were retrieved at each timepoint. To ensure the power and feasibility of our analysis, we have evaluated the expected sample size (number of samples) required to detect a difference of 0.5 Cohen's *d* (medium effect size, as suggested by Cohen and colleagues 2012), in a compositional comparison framework (pwr R package), with statistical power of 80% and 0.05 significance level. We have obtained that ~6 samples for each vineyard and timepoint would satisfy this condition.
