Unique Message Coding

For each of the 36 unique messages, code their distinct message identifier that people were talking about.

<u>Associated Message Identifier:</u> Distinct Type-Message#-Disease combo used to identify a certain message.

→Code the message whenever someone mentions that message whether alone or as a group. When multiple messages are talked about, code all of the messages mentioned.

For Ex: if they are talking about Expl-1A-Eso compared to Test-1B-Eso, we would code that section completely for Expl-1A-Eso and Test-1B-Eso
