Abstract



Surprisingly little is known about the incidence by age of childhood gastroenteritis in the United Kingdom. We were able to study this because of the cooperation of general practitioners who were enrolled in the Oxford Community Health Project and who keep detailed records of the age distribution of printients.

Tripp and Harries stated that 10% of children will have an episode



of gastroenteritis in their first year, based on the Registrar General's figures for 1958-72.* We not only found that 12.8% of children under 1 year had at least one episode of gastroenteritis, but so did 91% of children aged 1 to 2 years. These figures are likely to be underestimates since not all cases of gastroenteritis will present to the health visitor or general practioneer. The incidence was higher in children from urban than from semirural areas.
