Copyright Transfer Form: Clinical Cancer Research

The American Association for Cancer Research (AACR), Inc., obtains and owns the copyright to the contents of the journal Clinical Cancer Research (CCR). Under the terms of Copyright Law PL 94-553, which became effective January 1, 1978, AACR, Inc., must formally obtain transfer of copyright before an article can be published, unless the article was prepared as part of the author's official duties as an employee of the United States Federal Government.

Authors (and all coauthors) who publish in AACR journals retain the right to present orally in any forum all or part of the work and the right to republish parts of the work in any subsequent paper or book of which he/she (or any of the coauthors) is author or editor, subject to the author acknowledging the published source of the material.






