ANOVA Results for Table 2

For each behavior in each epoch, a between-within ANOVA was conducted with dose (6) as the between factor and day (2) as the within factor. F ratios and statistical significance level achieved are listed for each factor and for the dose X day interaction. Statistical analyses were conducted according to Kirk (1968).

Epoch 1 (0-30 minutes).

Grooming	dose: $F_{5,18}=2.47$, NS day: $F_{1,18}=56.07$, $p<0.001$ interaction: $F_{5,18}=5.35$, $p<0.01$
Motionless	dose: $F_{5,18}=5.40$, $p<0.01$ day: $F_{1,18}=41.82$, $p<0.001$ interaction: $F_{5,18}=4.56$, $p<0.01$

Epoch 2 (45-75 minutes).

Sniffing	dose: $F_{5,18}=4.40$, $p<0.01$ day: $F_{1,18}=25.18$, $p<0.001$ interaction: $F_{5,18}=2.04$, NS
Walking	dose: $F_{5,18}=5.70$, $p<0.01$ day: $F_{1,18}=21.43$, $p<0.001$ interaction: $F_{5,18}=4.52$, $p<0.01$
Grooming	dose: $F_{5,18}=3.65$, $p<0.05$ day: $F_{1,18}=0.01$, NS interaction: $F_{5,18}=1.34$, NS
Motionless	dose: $F_{5,18}=2.65$, NS day: $F_{1,18}=20.24$, $p<0.001$ interaction: $F_{5,18}=0.87$, NS

Epoch 3 (90-120 minutes).

Sniffing dose: $F_{5,18}=1.27$, NS
 day: $F_{1,18}=12.12$, $p<0.01$
 interaction: $F_{5,18}=0.81$, NS

Walking dose: $F_{5,18}=1.42$, NS
 day: $F_{1,18}=4.78$, $p<0.05$
 interaction: $F_{5,18}=0.84$, NS

Grooming dose: $F_{5,18}=2.50$, NS
 day: $F_{1,18}=2.00$, NS
 interaction: $F_{5,18}=2.27$, NS

Motionless dose: $F_{5,18}=1.39$, NS
 day: $F_{1,18}=2.20$, NS
 interaction: $F_{5,18}=1.87$, NS
