Business and Continuity of Operations online appendix Summary prepared November 2013

The original 13 questions defined by the Business and Continuity of Operations Panel at the June 2012 meeting are listed below:

 - c. Cash flow issues for hospitals while awaiting reimbursement
 - d. Agreements with CMS/payer prior to event
 - e. Domestic vs Intl response & payment
 - f. Displaced uninsured persons into hospital catchment area
- 7. What the implications of an EHR based system on provision of mass critical care
 - a. Surge capacity
 - b. Unique identifiers (patient transfer/evac implications)
 - c. Infrastructure vulnerability

 - e. Equipment data capture outside of the ICU
- 8. What special considerations are required regarding hospital/critical care unit relationships with vendors related to disaster preparedness/response?
 - a. Different facilities double counting surge supplies

- 9. What questions must critical care systems ask of their key partners regarding their partners' disaster preparedness?

Based on the above key questions, the Business and Continuity of Operations Panel was divided into 2 working groups, with focus on Medication and medical supply chain vulnerability, and information technology (IT) vulnerability in a disaster.

Medication and medical supply chain vulnerability

Initial literature searches were performed using the following search terms: shortages, medical supply chain, medications, drugs, and medical supplies. Timeframe: 2008 to February 2013

145 articles were found, and reviewed by Dr. Tosh and Dr. Dichter. 109 articles were felt to be relevant and all were pulled and reviewed.

There were no articles found in these literature searches felt to provide significant high-grade data addressing the key questions.

Information Technology Vulnerability

Initial literature searches were performed using the following search Terms:

Disaster preparedness health information technology (HIT)
Disaster preparedness informatics
Disaster preparedness electronic health record (EHR)
Disaster management HIT
Disaster EHR
Mass casualty EHR
Mass casualty informatics

Timeframe: 2008 to March 2013

Dr. Feldman and Dr. Dichter reviewed literature searches, and 10 articles were pulled and reviewed. Unfortunately, these searches were not kept nor were the total number of articles reviewed recorded. Of note, these seven search terms were entered into PubMed in November 2013, and 370 articles were obtained, which is a reasonable estimate of the number of articles actually reviewed in March 2013.

There were no articles found in these literature searches felt to provide significant high-grade data addressing the key questions.

Addendum regarding suggestions 19-21, which were omitted from the final manuscript.

The following 3 suggestions (19-21) were passed by ≥ 80% of the task force during the Delphi process first round. However, at the topic editors face-to-face Chicago meeting in April 2013 (between rounds 1 and 2), the Topic Editors felt that the Task Force felt did not have sufficient IT expertise to warrant these suggestions being included. It was decided at this meeting that they would be withdrawn as suggestions, but included in the manuscript's on-line supplemental material.

Original Delphi Suggestion 19: We suggest hospitals should have spare servers for a years worth of operations (these can be non-critical function servers that can be repurposed).

Original Delphi Suggestion 20: We suggest in an extended disaster (such as post-hurricane Katrina) plans need to be in place to continue computer support for patient care, finance, education, research operations, etc. from an IT standpoint, with sufficient storage and servers for anticipated growth.

Original Delphi Suggestions 21: We suggest hospitals and health systems inventory all computer systems that can be cannibalized in the setting of extreme shortage. Plans should be made for long-term relief of the effected systems in these non-critical areas to support long-term continuity.
