

Figure S3. Phylogenetic relationships of wheat *C3H* and *CCoAOMT* genes with the homologs from other species. Phylogenetic trees of *C3H* (A) and *CCoAOMT* (B) were generated based on nucleic acid sequence similarity of wheat genes with 15 *C3H* and 19 *CCoAOMT* genes, respectively, of other monocot and dicot species collected from the NCBI nucleotide database [39] using MEGA program [41], and the trees were inferred using Maximum Likelihood method based on the Tamura-nei model. The percentage of replicate trees in which the associated taxa clustered together in the bootstrap test of 500 replicates is shown next to the branches. ●, wheat candidate gene; ▲, genes from dicot species other than *Arabidopsis*; *, wheat sequence used for the analysis.
