Appendix 4: Examples of the type of methodological changes requested by peer reviewers and

author responses

BLINDING – positive impact on reporting

Peer review comments:

"Please clarity how was blinding procedure (participants, practitioners and outcome assessors) implemented?"

Author response:

"Outcome assessments were made by independent clinician blinded to group allocation and uninvolved in providing intervention or management."

RANDOMIZATION - no impact on reporting

Peer review comments:

"Concealment (or lack thereof) needs to be specified further."

Author response:

"Both expert echocardiographers and student tutors introduced themselves with their first names only and did not mention their qualifications. We added this information in the methods section."

SAMPLE SIZE - positive impact on reporting

Peer review comments:

"From where did the hypothesis of a 5% group difference arise? Is there a clinical basis for this decision? The authors should justify."

Author response:

"Due to space considerations we left out the 'workings' for our sample size calculations. The 5% difference was drawn from the literature and our previous research. We provide a summarised version of this in our manuscript"

PRIMARY AND SECONDARY OUTCOMES - positive impact on reporting

Peer review comments:

"In terms of the reporting – there are a large number of primary outcome measures – it isn't clear from the published protocol exactly which were primary. This needs clarifying."

Author response:

"The primary outcome measure used in the power calculation of this study was the Copenhagen Risk Score (CRS). We used a European risk calculation programme named PRECARD to calculate the absolute risk of CVD. The CRS is based on age, gender, BMI, history of CVD, Diabetes Mellitus, smoking status, systolic blood pressure, HDL and total cholesterol levels. We added text to clarify this in the text".

ADDITIONAL ANALYSES - negative impact on reporting

Peer review comment:

"Since the blood pressure lowering and vessel-dilating effect may be more significant in hypertensive patients than in normal blood pressure patients, the results may be more persuasive if including only mildly hypertensive patients."

Author response:

"This is an excellent point. We have performed a sensitivity analysis to look for any response differences between participants with highest and lowest blood pressure, and have added the following text to the results section."

ADDITIONAL ANALYSES – negative comment with no impact on reporting

Peer review comment:

"Why was no statistical analysis between the groups performed? It would be interesting to know if there were significant differences between Group A day 42 and Group B day 203."

Author response:

"No statistical analysis was performed between these groups because the study was not powered to assess this aspect, thus no conclusion can be drawn based on this exploratory analysis performed on the available sample size."

CONCLUSION - positive impact on reporting

Peer review comment:

"As regards the results, the conclusion is not actually borne out in the study. If there are no differences between the two interventions, one cannot conclude that one intervention is better than another."

Author response:

"We have altered the text to make clear that we are not making any false conclusions."

ADHERENCE TO REPORTING GUIDELINE - positive impact on reporting

Peer review comment:

"Adhere to CONSORT guidelines in more detail particularly in the results and discussion section accordingly to the information in the following link ..."

Author response:

"The structure of the paper has been revised according to the CONSORT statement: extension to cluster randomised trials. The results section has been detailed as it follows"
