Sanger sequencing chromatogram for patient 12007903, showing a heterozygous intronic variant in the *ABCA4* gene (chr1:94,476,951; *ABCA4* c.5461-10T>C, NM_000350.2). c.5461-10T>C is known to segregate with clinical presentation of IRD, ¹⁻⁴ but functional mechanism of pathogenesis is unknown.
