Figure S1. Sequence coverage map. Each curve represents the number of reads across each genomic position for one poliovirus strain. Sabin 1, 2, and 3 serotypes are displayed separately. Variants were called only when there were at least 500 reads (dotted line) across >95% of target positions in a given strain.
