Our sample size (43 participants) was chosen according to two factors: First, fMRI studies typically include close to 25 participants, which can be seen as a general minimum.

Second, we calculated the number of subjects needed for > 80% power using pilot data and the Neuropower tool

(<a href="http://neuropowertools.org/neuropower/neuropowerstart/">http://neuropowertools.org/neuropower/neuropowerstart/</a>). For uncorrected whole brain results, we would need 30 partipants, and under random field theory we would need 40. Hence we chose to recruit slightly over 40 participants.
