The sample size was minimized for ethical reasons. N=6 has been sufficient to allow parametric testing using t- and F-tests for large effects for characterizing the firing of place cells in mice running in VR (Chen et al., PNAS, 2013). These are observable biological properties rather than statistical parameters, so a formal power analysis was not indicated. We performed pilots experiments with single implants in CA1 (N=2) and mEC (N=3) to test the viability of the novel VR system to engender spatial firing patterns in either region, and made double implants in both regions (N=6) to maximize yield when confident of viability, given that not every implant can be guaranteed to yield spatial cells of the desired type.

A second experiment was required by referees, to check the generality of aspects of the results for which 4 further datasets were acquired.
