We do not use explicit power analyses in our manuscript since they do not apply to the information we wish to collect. Our crystallographic data uses statistical analysis to determine the quality of the experimental data and the fit to the presented models. A summary of these statistics is provided in Table 1 and complete validation files are provided for each structure.

For calculation of IP6 molecules per virion, an average ( $309 \pm 41$ ) was determined from viruses produced from 3 biological replicates (independent experiments conducted on different days).
