No explicit power analysis was used. Sample sizes were chosen such that the uncertainty in FRET fraction estimation is about 0.01, and exact sample sizes were stated in the figure legends.

Replicates

The number of cells (biological replicates) and kinetochores (technical replicates) are reported in each figure legend. Cells that display abnormal spindle morphology and/or low signal-to-noise ratio were excluded from analysis, as stated in Materials and Methods.

Statistical analysis methods are described in Materials and Methods section, mostly in Quantification and Statistical Analysis subsection. Exact values of N, definitions of center and dispersion measures are reported in each figure legend.
