No explicit power analysis was used. For in vitro experiment,  $\geq 3$  replicates were performed. For in vivo experiments,  $\geq 3$  animals were used in each group. The number of replicates is well-accepted in this field.

For in vitro part, more than three independent differentiations were performed for each cell line. The quantification of fluorescent images was analyzed by Image J. For each cell line, more than 1,500 cells for each index were counted. For grafted cells, more than 2,000 hN+ cells were counted in each index, n (V-CON) = 4, n (V-LHX6OE) = 5). All detailed data could be found at section **experimental procedures** from manuscript. Data were excluded only in the case of obvious technical error.

Data were compared by Student's t-test, one-way ANOVA, and two-way ANOVA. All graphical data were presented as mean  $\pm$  SEM. Values were considered statistically significantly different at  $p < 0.05$  (\*),  $p < 0.01$  (\*\*), and  $p < 0.001$  (\*\*\*) . N values were described in figure legends.
