We based our sample size based on papers that investigated the interaction between repetition suppression and predictive error (N=16, Summerfield, et al. 2008) and forward encoding modelling of MEEG for orientation selectivity with a comparable number of trials as the current study (N=10; Myers, et al. 2015).

Each participant had two sessions where EEG was recorded (p. 6) with each session consisting of 2700 trials.

All statistical tests were designed to show the effects were reliable across participants.

No outliers were excluded from the analysis.
