No explicit power analysis was used in these studies. We determined sample size and number based on conventional gnotobiotic standard practice and experimental feasibility. This information is not specifically referenced within the submission document, as we do not believe it applies to our biological studies. For all mouse-related figures a minimum of five samples was used throughout the paper. We affirm that these numbers appropriately reflect the standards for gnotobiotic studies.

Each experiment was performed at minimum twice throughout the paper. This information can be found in the detailed methods section. Sample size can be found in the figures depicted as individual dots or symbols where each dot represents data from an individual mouse as biological replicates. For example, figure 1b shows n=6 WT and n=7 T300A mice. Where data for specific taxa are shown, for example 3a, 3b those data reflect mice from figure 2b, which is clear and explicit from the figure text and legends associated with figure 3. Each figure therein has individual dots that represent the number of mice used. We did not encounter any outliers throughout the paper and as such, did not reference any means of elimination in the final submission document. Human microbiome data is publicly available from the Jostins et al. paper as referenced in the text and mouse microbiome data has been submitted to SRA SUB 4222585 as mentioned in the methods of the submission document.
