Information on replicates is available in methods section titled "Genetic and pharmacological treatments". In order to make clear that we mean biological replicates – we include there, sentences of the form "This stress was measured on *n* separate occasions (independently cultured and plated imaging dishes)". In each imaging run, cells were picked randomly to image.
