# Amendment to the research project "UBE 2016-00771"

Dear Prof. Perruchoud,

It is our pleasure to submit to you an amendment to the research project entitled "Occupational exposure to pesticides and their effects on the health of workers in conventional and organic farms in the area Zarcero" (your reference number UBE 2016-00771), for evaluation and approval by EKNZ.

The initial research protocol has been evaluated and approved by the EKNZ the Comité Ético Científico Universidad Nacional (CECUNA) in Costa Rica. The board stated that there are no principal ethical concerns with the protocol for our study in Costa Rica (a middle-income country). In the meantime the field work component of this study has been conducted successfully and we are now analyzing the data.

We now would like to apply the same methodology the Wakiso district in Uganda (a low-income country) between March 2017 and December 2018. Therefore, we adapted the protocol and added information on the second study site, while leaving the methodology otherwise as it was. We added in the title the study site "Wakiso in Uganda". Moreover, we will conduct an extensive pilot testing of the tools (information material, questionnaire, study tools) and will adapted them afterwards in accordance with the new context. In parallel we also submit the protocol to the "Higher Degrees, Research and Ethics Committee of Makerere University School of Public Health" in Uganda to obtain local ethical approval.

In brief, our research in Uganda is mainly marked by cross-sectional surveys to examine if the occupational exposure to pesticides harms the health of the farm workers in conventional and organic horticultural farms. Therefore, we aim to enrol 150 agricultural workers from conventional farms and 150 agricultural workers from organic farms that are visited by the research group on two occasions.



At the first visit we will (i) administer a structured questionnaire containing questions about socio-demographics, occupational history etc.; (ii) conduct neurobehavioral tests (e.g. short inventory of symptoms) with a simultaneous evaluation of brain function via

near-infrared spectroscopy (NIRS; in a subsample of the participants); (iii) obtain anthropometric parameters and blood pressure; (iv) measure the activity of the enzyme acetylcholinesterase; and (v) collect urine for quantification of pesticide and manganese metabolites. During a second visit (~1 month after the collection of primary samples) we will collect repeated urine samples and test the activity of the enzyme acetylcholinesterase. In addition, we will collect toenail and hair samples and administer a short questionnaire about recent pesticide exposure.

The results of the study are returned to the participants through written and verbal communication. The general results are returned to the communities in the region and to other stakeholders through restitution workshops, scientific articles in international magazines, presentations in national and international congresses and mass media.

We feel that the above described amendment to the protocol is straightforward and the involved techniques and interventions are the same and pose minimal risks from an ethical point of view and belongs to the Risk Category A (lowest risk) as with the initial protocol.
