Statistical reporting

- Report exact p-values wherever possible alongside the summary statistics and 95% confidence intervals. These should be reported for all key questions and not only when the p-value is less than 0.05.

The statistical tests for all experiments are indicated in the figure legends and exact p-values can be found in the Suppl. Table 2. The values for N are indicated above each graph in the figures. Graphs display the mean +/- SD for quantitative datasets or just the mean for qualitative datasets.
