Sample size about animal number and cell number for each group is described in the methods or in the figures' legends. While sample sizes used in this study were not pre-determined by statistical means, they are similar to the standard practice within the field.

As described in methods section, each mouse underwent behavior tests and calcium recording once. Predator odor could only be used once since repeated use may cause adaption and reduce the effect of triggering cataplexy. Exclusion of individuals was based on the histological verification of viral expression and GRIN lens tip location.
