Population characteristics	The group of 80 sedated patients (49 women, 31 men; mean age 52.8yrs. used in this prospective, observational, single-center, routine care study were all from the Lariboisiere Hospital (Paris, France). Data were collected between January 2018 and May 2018.
Recruitment	Patients were admitted for a non-emergency elective neuroradiology or orthopedic surgery. Pregnant women, minor patients (<18 yr.), patients with a Body Mass Index (BMI) > 35 and patients sedated under mechanical ventilation at the time of their management were excluded from the study. In agreement with the ethics committee for this non-interventional study an information letter was given, and an oral agreement was obtained from each patient before anesthesia.
Ethics oversight	This study was approved by the Institutional Review Board of La Societe de Reanimation de Langue Francaise (CE SRLF 11-356).
