The 14 antimicrobial peptides investigated in the laboratory evolution were chosen to cover diverse chemical structures and sources. 12 antibiotics representing a diverse set of antibiotic classes and mechanisms of action were chosen as positive controls for resistance evolution. The number of antimicrobials investigated met with the standards of previously published studies in the field of antimicrobial resistance research (e.g. DOI: 10.1126/scitranslmed.3009940, DOI: 10.1093/jac/dkw381).
