Statistics are not done across number of animals, but across number of neurons collected (as common in system neuroscience). Power analysis was not computed prior to the experiments. The number of well-isolated single neurons collected per animal and per brain area in this study is several hundred and exceeds the typical number (very few dozen) by far.

Described in Methods: We performed 40-50 experimental sessions per animal. In each session, we recorded neural activities while monkeys were performing the task. We did in no way pre-select the neurons we recorded from based on their neural properties. All units were included in the initial analyses. Partly, subsets of neurons (e.g. motor-goal neurons) were included in subsequent analyses, for which the inclusion criteria a defined in detail in the manuscript.

All general linear mixed model (GLMM) results are written in the main text (for readability truncated in 3 levels; p<0.05, p<0.01 and p<0.001). Multiple comparison results are shown with asterisks in figures. All multiple comparisons are Bonferronicorrected, as stated in Methods.
