Study description	The study is a controlled experiment with 6 soil treatments replicated 8 times each set up within a single greenhouse in a complete randomized block design.
Research sample	The study includes 48 experimental microcosms (8 replications of 6 soil treatments). The 6 soil treatments were designed are a

Research sample	sequential sieving and dilution of soil communities to near extinction. The 6 treatments represent a strong sequential gradient across which effects of soil biodiversity loss on soil functions can be assessed.
Sampling strategy	The 8 replicates per treatment were chosen because that was the maximum number of experimental units available that would fit into a single greenhouse compartment.
Data collection	All sample collection from the microcosms at the end of the experiment was performed by the first author (CW). All nutrient analyses (plant and leachate) were collected by the lab technician following standard protocols. Soil DNA extraction and PCR were performed by CW and EK at the Netherlands Institute of Ecology (NIOO). Next generation sequencing was done by Mycrosynth, Switzerland, and bioinformatics were done by KS.
Timing and spatial scale	Plant and soil communities were allowed to establish over a 24 week period after which the microcosms were destructively harvested at which time all plant and soil data were collected.
Data exclusions	There were no data exclusions.
Reproducibility	This experiment was reproduced twice in a paper previously published (Wagg et al. 2014, PNAS 111:5266-). Here we collected new additional data from this experiment (e.g. we performed next generation sequencing to analyse the soil microbiome, analysed new variables and we asked new research questions about the importance of microbial network complexity and bacterial-fungal associations in driving ecosystem functioning. We used cross validation and randomization tests to assess the computational reproducibility/robustness of the indices's generated.
Randomization	Treatments were set up in a complete randomized block design.
Blinding	All samples taken were labeled with a single number to track samples during lab processing and sequencing, but included no information as to the treatment from which it originated.
