Sample size information can be found in Materials and Methods and figure legends. Sample size was decided based on common practice in the field. For example, all PSI knockdown and overexpression experiments, we performed at least 3 independent experiments with a total of at least 18 flies. All qPCR experiments were performed at least three times with three technical replicates/samples.
