We used TASSEL V3.0 to analysis the association between the variations and leaf Na<sup>+</sup> concentration, MEGA V6.0 to generate the phylogeny tree. HaploView V4.0 to analysis the LD relationship between variants, a mixed model approach implemented in TASSEL for GWAS analysis
