For all experiments the sample size has been clearly indicated in both the figure and figure legends.

No data were excluded from the analysis.

For experiments in vivo using injections, the virus injection site was confirmed before the experiment for every mouse. Mice with injection sites that were off from the desired brain region have been excluded from the analysis. The exclusion criteria were pre-determined before any experiment.
