"The platform will include a server that centralizes all the data and business rules, a website dashboard for health professionals, and a mobile application for patients. We will analyze the effects of its use through a controlled, non-randomized, non-blind, prospective, and monocentric clinical trial. We will enroll 56 participants diagnosed with arterial hypertension and under medical follow-up, divided into two groups. The participants of the Intervention Group will use the platform as a monitoring method, while the participants of the Control Group will use conventional methods. In both groups, we will assess and compare the evolution of blood pressure and treatment adherence before and after the intervention."
