Sample size of 6-10 mice per experimental group was empirically determined based on established model of experimental autoimmune uveitis for immunizations of WT B6 strain, also based on 3R guiding principles for ethical use of animal testing. Sample size is included in each figure legend and graphically depicted by individual dots (1 dot per biological sample). Sample size for the posthoc analysis of human serum samples was based on available frozen archived male and female patient samples from cohorts of clinically defined patients and healthy controls.

Each experiment was performed at minimum three times to ensure consistency of observed results. Biological replicates indicate individual animals, whereas technical replicates are the same samples tested multiple times. Outliers were excluded using GraphPad Prism outlier calculator. Experiment replicates can be found in figure legends

Animals were allocated into experimental groups by evenly distributing the same number of animals by sex and age. Masking was used, clinical and histology scoring were assessed in a blinded fashion. Samples were identified by ID number and not treatment method during analyses.
