Objectives	4 Clearly describe the primary and any secondary objectives of the study, or specific hypotheses being tested.	included in the manuscript

Ethical statement	5 Indicate the nature of the ethical review permissions, relevant licences (e.g. Animal [Scientific Procedures] Act 1986), and national or institutional guidelines for the care and use of animals, that cover the research.	included in the manuscript
Study design	6 For each experiment, give brief details of the study design including: <ol style="list-style-type: none"> <li>The number of experimental and control groups.</li> <li>Any steps taken to minimise the effects of subjective bias when allocating animals to treatment (e.g. randomisation procedure) and when assessing results (e.g. if done, describe who was blinded and when).</li> <li>The experimental unit (e.g. a single animal, group or cage of animals).</li> </ol> A time-line diagram or flow chart can be useful to illustrate how complex study designs were carried out.	included in the manuscript
Experimental procedures	7 For each experiment and each experimental group, including controls, provide precise details of all procedures carried out. Sample size	10	<ul style="list-style-type: none"> <li>a. Specify the total number of animals used in each experiment, and the number of animals in each experimental group.</li> <li>b. Explain how the number of animals was arrived at. Provide details of any sample size calculation used.</li> <li>c. Indicate the number of independent replications of each experiment, if relevant.</li> </ul>	specified for each experiment in the Results and Figure legends
Allocating animals to experimental groups	11	<ul style="list-style-type: none"> <li>a. Give full details of how animals were allocated to experimental groups, including randomisation or matching if done.</li> <li>b. Generalisability/translation	19	Comment on whether, and how, the findings of this study are likely to translate to other species or systems, including any relevance to human biology.	included in the manuscript
Funding	20	List all funding sources (including grant number) and the role of the funder(s) in the study.	included in the manuscript
