All participants had acquired basic GI theoretical knowledge in their previous years of study, but they could not perform gastroscopy at all and confirmed that they had not yet received systematic professional education in gastroscopy because the GRS was designed for primary learners. In addition, they needed access to a procedure on their own computers to operate the sample version of the e-learning system.
